# Tentative Translation

Japanese Agricultural Standard for Easily Chewable and Swallowable Foods

Established: Notification No. 1568 of August 17, 2016.

## (Scope)

Article 1: Among easily chewable and swallowable foods, this standard applies to easy-to-chew foods, foods that can be chewed by the gums, foods that can be chewed by the tongue, and foods not requiring chewing.

### (Terms and Definitions)

Article 2: In this standard, definition of the terms listed in the left column of the following table is provided in the right column of the table.

Terms	Definition
Easily Chewable and	Processed foods that can be chewed with less effort compared with ordinary
Swallowable Foods	foods due to their properties and qualities such as hardness (excluding baby foods)
Easy-to-Chew Foods	Easily chewable and swallowable foods with such hardness that allows easy biting, crushing, or grinding (limited to those having certain chewiness)
Foods that can be Chewed by the Gums	Easily chewable and swallowable foods with moderate hardness between the easy-to-chew foods and the foods that can be chewed by the tongue
Foods that can be Chewed by the Tongue	Easily chewable and swallowable foods with hardness such that the food can be chewed between the tongue and the palate
Foods Not Requiring Chewing	Easily chewable and swallowable foods with hardness that allows swallowing without chewing

(The Standard for Easy-to-Chew Foods) Article 3: The criteria of easy-to-chew foods are as follows:

	Labeling method	In addition to the requirements of the Food Labeling Standards, for the methods of labeling for easiness to chew, cooking method, and net contents or drained weight and total contents, the following specific provisions apply:  (1) easiness to chew:     "easily chewable" shall be declared on the label;  (2) cooking method:     the cooking method shall be declared according to the characteristics of the food;  (3) net contents or drained weight and total contents:     net contents or drained weight and total contents shall be declared according to the labeling method prescribed in the lower column of the row, net contents or drained weight and total contents, in the Table of paragraph 1 of Article 3 of the Food Labeling Standards; provided, however, among the foods listed in the upper column of the appended Table 4 of the Food Labeling Standards, in the case of foods that include net contents in the middle column, labeling information, net contents or drained weight and total contents shall be declared according to the labeling method prescribed in the lower column of the same row.
	Presentation of mandatory information	In addition to the requirements of the Food Labeling Standards, the easiness to chew, the cooking method, the net contents or the drained weight and the total contents shall be declared on a part of the container or the package so as to be easily seen (on a part of the container or the package so as to be easily seen or in the invoice if the product is intended for business use).

Article 4: The criteria of foods that can be chewed by the gums are as follows:
